

# Certificate for Employment Intermediaries (CEI) Course

The Certificate of Employment Intermediaries (CEI) aims to equip employment agency (EA) personnel with knowledge of employment laws and regulations. This ensures that EA personnel understand their obligations under the law and are able to advise their clients of their rights and responsibilities. Participants will have the option to take the CEI Test without attending the CEI course, once. Should they fail the test in their first attempt, they must attend the CEI course before taking the re-test. Participants can sit for the CEI Test, any number of times, after having attended the course once. Participant must register with MOM Approved Test Administrator to sit for the CEI Test.
