

Class A UAPL Practical Assessment (up to 25kg)

This assessment is conducted in accordance with the requirements set by the Civil Aviation Authority of Singapore (CAAS) for the issuance of a Class A Unmanned Aircraft Pilot License (UAPL) 7kg and 25kg. The assessment evaluates the candidate's ability to safely and competently operate a rotorcraft UA through a combination of ground-based and flight-based tasks. Candidates will be assessed on pre-flight planning and preparation, airspace and operational awareness, aircraft inspections, manual flight manoeuvres without GNSS assistance, emergency procedure handling, and post-flight actions. The flight assessment typically includes precision hovering, climbing and descending circuits, figure-of-8 manoeuvres, directional control, and precision landing exercises. Candidates must demonstrate sound airmanship, situational awareness, adherence to safety procedures, and competency in operating the UA in accordance with applicable regulations and operational requirements. Successful candidates who have also fulfilled all theory requirements may be eligible for the issuance of Class A UAPL, subject to CAAS requirements.

Target Audience: Working professionals require by law to hold a UAPL for commercial drone operations; site engineers, project managers, and surveyors deploying drones for inspection or mapping; videographers and content creators operating commercially; security and emergency response personnel; company-sponsored employees upskilling for business needs; career changers and fresh graduates from Polytechnic or ITE seeking to enter the drone industry; and SkillsFuture learners pursuing new competencies in an emerging technology field.

Entry requirements:

Learners hold a Class A UAPL limited to 7kg

Learners must provide evidence of completion of practical training for 25kg multi-rotor operations, or must have completed Class A UAPL (Rotorcraft) up to 25kg (Practical Training)

Learners are assumed to be minimum **16** years old

Learners shall minimally have the following skills and knowledge WPLN4 – English – Level 4 for reading, listening, speaking and writing)

Assessment Duration: 1 Hour. Passing criteria: 100%. Medium of Instruction – English.
